

# American Connemara Pony Society Halfbred Registration Application

For geldings and mares - A one-time registration process. Fee is \$85 for a permanent certificate includes Microchip and USEF Lifetime Number.  
Fee for halfbred colt to age 2 is \$85. A Temporary Foal Certificate will be issued. If gelded before age 2, the fee for permanent registration is included in the \$85.

If not gelded before age 3, the fee for a Halfbred Stallion Permanent Certificate is \$250 and includes DNA sample, microchip, and USEF Lifetime Number.

The fee for a stallion after age 3 is \$500 and includes DNA sample, microchip, and Lifetime USEF Number. ALL FEES ARE DOUBLE FOR NON MEMBERS OF ACPS  
For a Halfbred Stallion - a veterinary inspection form must be completed by a veterinarian certifying there are no unacceptable inheritable traits. Find that form at [www.acps.org](http://www.acps.org)
